The DCPA began in affiliation with the Gold Prospectors Association of America aka GPAA. We then added Mining and Treasure Seeking Education as well as other Charitable Activities, such as sending kids with cancer to Camp Millennium.

It was apparent we needed to be separate from the GPAA so the Douglas County Prospectors Association Corporation, better known as DCPA, was formed. We are chartered in Oregon.

We hold many outings, projects, trips and activities throughout the year. When more are added, the unpopular ones are dropped. "The Sluice Box", our monthly newsletter informs members of these activities as well as other items, photos, memos and correspondence or articles submitted by members.

The DCPA is a family association. We keep the dues low and supplement funds through projects, drawings, auctions and donations. We sponsor our annual Southern Oregon Gold and Treasure Show in the spring. Prospectors and Treasure Seekers can see the many new products, methods and demonstrations or talk with experienced club members who are more than willing to share their knowledge. The club relies on its members to volunteer as Officers, Board Members, serve on committees and help with the various projects that make the DCPA one of the top associations of its kind in the Western US. To date, our largest membership has been 371. To be considered active, all members are asked to attend at least four activities during the previous twelve months.

Camp Millennium, a 7-day camp for kids with cancer has been our primary charity for quite a number of years. Our activities pay the way for many to attend camp which is held about 20 miles NW of Roseburg. Several club members participate spending a full day there teaching classes on the Art of Gold Panning. We always make sure that each kid finds and keeps their gold in the vial we provide.

DCPA meets on the 2nd Monday of each month at the Pine Grove Community Church, 1729 Buckhorn Road, Roseburg, OR 97470 at 7:00 pm. There is an optional potluck starting at 6:30. The board meeting is at 6:00 and open to all members. Yearly dues are \$12 for individuals or families.
